Parent/Guardian: As the parent/guardian of this student, I have read this Chromebook loan contract. I understand that this device is designed for educational and enrichment purposes while participating in school. I recognize that it is impossible for SSEC to restrict access to all controversial and/or inappropriate materials and I will not hold SSEC responsible for materials acquired on this device. These devices **are not to leave SSEC building locations**. Further, I accept full responsibility for my child's device if found outside of the school building. I hereby give permission to issue a loaner device for my child and certify that the information contained on this form is correct.

Both Student & Parent/Guardian: I understand that I am solely responsible for the care of the device until it is turned back into SSEC. I understand that these devices **are not to leave SSEC building locations**. I understand that **I will bear the cost of restoring the equipment (including accompanying licensing)** if it is damaged. I understand and agree that if the equipment is damaged beyond repair or that I am unable to turn it in in working condition, reasonable wear and use is expected, that **I will pay SSEC for the replacement of the device and its accompanying google education license**. The most recent version of Chromebook's distributed to students at SSEC cost \$329. The current cost of the education management licensing is \$32.
